## **INTELLECTUAL DEVELOPMENTAL DISABILITIES**

When an individual enters Innovative Homes of Deep East Texas, Inc. HCS program, a level of need is determined and a individual plan of care is identified for the individual. A LON is determined by completing a ICAP which is a scoring instrument used to identify strengths and weakness. It provides the program with important information about the level of care he or she will receive while attending the HCS program. The IPC is established by a Programming Team of professionals. A Programming Team consist of the individual, nurse, LAR, and other professionals that may be important in developing the IPC. Services are established based on recommendations from the team. The team oversee's the plan.

## **PROGRAM ADVOCATE**

Program Advocate services are provided to enable individuals to remain in a community setting. Each individual is assigned a program advocate by the program provider. Program Advocate is responsible for ensuring the individual choices and services are met. They are the primary link between the individual and community.

## **HOME & COMMUNITY BASED SERVICES**

Home and Community based services offer special assistance to people with intellectual developmental disabilities who are at risk of placement in State Supported Living Centers. HCS programs assist individuals and their families by providing residential support services, program advocate, nursing, day habilitation, transportation, respite, and a whole host of other support services to help the consumer remain in the community.

## **GROUP HOMES**

Group homes provide a safe and quality home setting for individuals with intellectual developmental disabilities who are in need of structured, but least restricted environment. Individuals receive training and assistance as needed in performing basic self help and home management skills. Residents are also involved in activities outside of the home such as vocational services, supported employment, and community activities. Family members are encouraged to participate in treatment planning and family visits.

## **DAY PROGRAMMING**

Training goals and objectives are established in a effort to help enhance the individuals daily living skills such as self medicating, personal hygiene, washing and ironing clothes, preparing meals, cleaning house, grocery shopping, and money management.

## **RESPITE**

Respite is available to individuals who are living in their family home. Respite is provided on a planned or emergency basis when the person normally responsible for providing care is unable to do so.

## **COMMUNITY AWARENESS**

Individuals frequently participate in community activities such as attending a church of their choice, eating out at public restaurants, attending public schools, visiting public libraries, and shopping in public stores.

## **VOCATIONAL SERVICES**

We offer pre-vocational and vocational services. Individuals receive on the job training in such areas as packaging, manufacturing work, landscaping and janitorial services.

## **SUPPORTED EMPLOYMENT SERVICES**

We offer supported employment which is paid competitive employment at minimum wage and above.

## **HCS/FOSTER COMPANION CARE**

Is provided in a residence by a foster or companion care provider exclusive of Texas Department of Human Services foster care programs

## **RECREATIONAL ACTIVITIES**

We celebrate every individual's birthday with cake, punch, and lots of food. We host bowling and golf tournaments and often visits the ranch to see the animals.
