With more than 2,100 staff, we are proud to deliver personalized care through 40+ programs and services to unserved and underserved populations with a wide range of diagnoses.

We provide care and support through four service divisions: Mental Health Outpatient Services, Mental Health Forensics, Intellectual Disability & Autism Services, and Comprehensive Psychiatric Emergency Programs. We serve over 48,000 individuals each year, about 4,500 of whom are children. While we can only count the number of individuals we serve, we know our impact extends to their entire community.

Children's Mental Health Services

Mental illness can affect people of any age, including children. It can make life at school, home and in the community difficult for your child, but it can also challenge you as a parent. It's important for you to know that The Harris Center is here to help you. We have two children's mental health outpatient clinics:

- Southwest Community Service Center, 9401 Southwest Freeway, Houston
- Southeast Community Service Center, 5901 Long Drive, Houston

Services may also be provided in your child's home and school and through our co-location clinics.

Referrals, eligibility screenings and intakes are conducted only at the 4th floor of our Southwest Community Service Center.

Frequently Asked Questions

How can I receive services?

Please call the [Patient Information Line](#) at **713-970-7000, option 2**, or visit the 4th Floor of the Southwest Community Service Center located at 9401 Southwest Freeway, Houston, 77074, between Monday to Friday from 7:30 am to 3 pm. No appointment is needed, and walk-ins are processed until daily slots are filled on a first-come, first-served basis.

Calling the Patient Information Line before you visit the clinic is encouraged to make sure you know the entire list of documents that you must bring based on your case.

Some of these documents include:

- Proof of Harris County residency
- Proof of income and/or support
- Proof of insurance
- Personal identification

Services provided are determined by your diagnosis, symptoms and functioning at home and in the community, and availability of services at The Harris Center.

What services are available?

- Mental health assessment
- Medication-related services
- Routine case management
- Intensive case management
- Parent and child behavior-management skills training
- Counseling (Cognitive Behavior Therapy)
- Parent partners (peer support for parents)
- Crisis management
- Juvenile Justice mental health services (institutional and community-based)

Might I be eligible for services?

To be eligible for services, your child must be residing in Harris County, be between the ages of 3 and 17 and have a diagnosis of mental illness that creates a serious functional impairment at home, school or in the community.
